NOTICE OF APPOINTMENT OF SUCCESSOR ARCHITECTURAL CONTROL COMMITTEE

This Notice of Appointment of Successor Architectural Control Committee (this "Notice") is made as of this 15 day of _______, 1998, by The Dobson Association, Inc., an Arizona nonprofit corporation (the "Association").

RECITALS

- A. The Association is the community association for the master planned community known as Dobson Ranch located in the City of Mesa, Arizona ("Dobson Ranch"). The members of the Association are the record owners of lots and condominium units within Dobson Ranch.
- B. As part of the establishment of a general plan for the development and use of Dobson Ranch, Declarations of Covenants, Conditions and Restrictions were recorded with the County Recorder of Maricopa County, Arizona, against the various subdivisions within Dobson Ranch. Such Declarations of Covenants, Conditions and Restrictions are described on Exhibit A attached to this Notice. Each such Declaration shall be individually referred to in this Notice as a "Declaration", and all such Declarations shall be collectively referred to in this Notice as the "Declarations".
- C. Each Declaration provides that the aesthetic quality of the property subject to the Declaration shall be maintained by an Architectural Control Committee. Each Declaration set forth the names of the initial members of the Architectural Control Committee and provides a method for appointment of their successors. Each Declaration provides that the rights, powers, duties and liabilities of the Architectural Control Committee shall terminate on the date specified in the Declaration unless prior to such termination date a written instrument shall have been executed by the then owners of a majority of the lots in the subdivision subject to the Declaration appointing a successor committee which shall thereafter exercise the same rights and powers, and shall have the same duties and liabilities, as previously exercised by and imposed upon the Architectural Control Committee.
- D. The owners of a majority of lots in each of the subdivisions subject to a Declaration have executed a written instrument appointing the Dobson Ranch Architectural Committee as the successor committee to the Architectural Control Committees established by the Declaration.
